MEMBERSHIP CLASSIFICATIONS

Article I Members

Section 1. **Eligibility for Membership.** To be eligible for membership a person must be either:

1. the owner directly or indirectly of at least an undivided one half interest in a lot or dwelling unit on Lido Isle or a ground lessee thereof; or
2. the lessee of a dwelling on Lido Isle for an original term of one (1) year or more and be a resident; or
3. the adult child of a member; or
4. the adult grandchild of a member if the applicant's parents are deceased; or
5. a Junior Member in the preceding year; or
6. previously a Member or Junior Member.

Section 2. **Election of Members.** Individuals age of eighteen (18) years of age and older shall be elected to membership upon favorable recommendation of the membership committee and an affirmative vote of two-thirds (2/3) of the Directors present at a regular or special meeting of the Board of Directors.

Section 3. **Classes of Members.**

1. **Regular Members.** Adult members who own or reside on Lido Isle are Regular Members.
2. **Associate Members.** Adult members who do not own or reside on Lido Isle are Associate Members.
3. **Young Regular or Young Associate Members.** Members eighteen (18) years of age and over and under thirty (30) years of age shall be known as Young Regular or Young Associate Members, and shall otherwise have all the rights and privileges of those without the designation "Young."
4. **Junior Members.** Junior Members may be granted to each person under the age of eighteen (18) years of age who is the child or grandchild or issue within the third degree of a Regular or Associate Member. Such Junior Member shall convert to Young Regular or Young Associate Membership as applicable upon the holder attaining eighteen (18) years of age. There shall be no initiation fee for converting to such adult membership.

Section 4. **Voting Rights.** Each Regular Member (for the purposes of voting rights, husband and wife shall have one (1) vote between them) shall be entitled to one (1) vote on each matter submitted to a vote of the members. No members other than Regular Members shall be entitled to vote.

Section 9. **Reinstatement.** Upon written request of a former regular, associate or junior member filed with the secretary, the Board of Directors, by the affirmative vote of two-thirds (2/3) of the members of the Board, may reinstate such former member upon such terms as the Board of Directors may deem appropriate, including, however as a maximum requirement, (a) payment of an amount equal to three times the current year's dues (in lieu of the initiation fee) and (b) payment of the current year's dues, subject to the classification of membership as defined in Section 3 of this Article I. The seniority of the reinstated member for purposes of club number shall be as of the date of reinstatement.

Section 10. **Transfer of Membership.** Membership in the Club is not transferable or assignable.

Section 11. **Spouses.** The spouse of a Regular or Associate Member shall be entitled to all the privileges and immunities of membership to which the Regular or Associate Member is entitled. After a judgment dissolving a marriage of a member, both parties to the marriage so dissolved may continue as members; no additional initiation fee shall be required for either party. On the death of member, his or her spouse shall automatically have such decedent's membership.

Note: The Club reserves the right to amend its Bylaws at any time and from time to time, which includes the right to alter, amend or change the classes and qualifications of members.
